On April 17, 2015, OCI Resources LP (the "Partnership") issued a press release announcing the declaration of its first quarter 2015 distribution. A copy of the Partnership's press release is attached hereto as Exhibit 99.1 and incorporated herein by reference.

In accordance with Treasury Regulation 1.1446-4(d), a qualified notice was issued to the New York Stock Exchange indicating that this distribution represents income effectively connected with a U.S. business (ECI) and that all nominees are responsible for withholding 35% of the fiscal 2015 first quarter distribution to foreign investors (nonresident aliens, foreign corporations, foreign trusts and foreign estates) as required under Section 1446 of the Internal Revenue Code.
